# **Summary of key findings for parents**

#### The provision does not meet requirements

- The childminder has insufficient knowledge of the Local Safeguarding Children's Board procedures for acting on concerns about a child's welfare. She does not have a policy regarding use of mobile phones and cameras, which is also a requirement.
- The childminder does not have a valid paediatric first-aid certificate. This fails to promote children's well-being and is a breach of the Early Years Register and the associated requirements of the Childcare Register.
- The childminder does not have sufficient understanding of how to complete assessments of children's progress in order to plan for their individual learning needs.
- The childminder has failed to notify Ofsted of the birth of her second child. This is a breach of requirements but Ofsted does not intend to take any action on this occasion.
- The childminder has good knowledge and understanding of how to support children's learning through activities such as cooking, gardening, arts and crafts, and role play.
- The childminder is committed to contacting the local early years advisory service to help improve her practice.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

### To meet the requirements of the Early Years Foundation Stage the provider must:

- improve knowledge in order to implement a safeguarding children policy and procedure that is in line with the guidance and procedures of the Local Safeguarding Children Board and that covers the use of mobile phones and cameras in the setting
- obtain a current paediatric first-aid certificate relevant for those caring for young children and babies
- improve knowledge and understanding of the assessment requirements.

#### To meet the requirements of the Childcare Register the provider must:

- improve knowledge in order to implement procedures to be followed for the protection of children, intended to safeguard the children being cared for from abuse or neglect (compulsory part of the Childcare Register)
- obtain an appropriate first aid qualification(compulsory part of the Childcare Register)
- improve knowledge in order to implement procedures to be followed for the protection of children, intended to safeguard the children being cared for from abuse or neglect (voluntary part of the Childcare Register)
- obtain an appropriate first aid qualification(voluntary part of the Childcare Register).

### **Inspection activities**

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and how she will meet the safeguarding and welfare requirements.
- The inspector looked at the policies and procedures, records and documentation the childminder has for use when caring for children.
- The inspector checked documentation relating to the suitability of the childminder and other adults living in the household.
- The inspector checked the suitability of the premises, including play resources.

The childminder registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register in 2011 She lives with her husband and two children, one of whom is of school age. Children use the living room, kitchen and enclosed garden for play activities. The childminder uses one bedroom on the first floor for young children to sleep. The bathroom is on the first floor.
