Summary of key findings for parents

The provision meets requirements

- The manager has good knowledge and understanding of how to plan suitable activities for children of different ages and abilities.
- The manager and staff know how to organise an environment that is safe, welcoming and offers stimulating resources that reflect the children's interests.
- The manager understands how to promote children's good health and hygiene. She knows the vital importance of identifying and minimising all risks in the environment used by children.
- The manager and staff team have attended child protection training. They understand how to protect children's welfare, and how to make a referral regarding any concerns.
- The manager understands the need to have effective systems for evaluating the provision to identify and address areas for improvement.
- The manager has established good partnerships with the school staff and parents to know and support children's individual learning and care needs.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed all areas used by the children.
- The inspector held discussions with the manager about how they deliver the safeguarding and welfare requirements of the Early Years Foundation Stage for children, including behaviour management.
- The inspector checked evidence of the suitability and qualification of the staff, viewed documentations such as, children's records, policies and procedures and self-evaluation processes.
- The inspector discussed with the manager how staff deliver the educational programmes for children.

Cherry Tree Kids Club GB Ltd (Brampton Primary) registered in 2008. It is one of six settings privately owned and managed by Cherry Tree Nursery GB Ltd. The club is registered on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. The club operates from a classroom within Brampton Primary School. The provision consists of a breakfast club, which operates from 7.45am to 8.55am, and an after school club, which operates from 3.15pm until 6pm. Both facilities are available to children attending the school. There are nine members of staff, six of whom hold relevant childcare qualifications. There were no children in the early years age group present at this inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
