Summary of key findings for parents

The provision meets requirements

- The childminder demonstrates a sound knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. She talks confidently about how she intends to provide children with interesting and challenging learning experiences, which will meet children's individual needs, once she recommences childminding.
- The childminder demonstrates a good awareness of child protection procedures and recognises the possible signs that children may be at risk from abuse. She further safeguards children by making sure her home is safe, by completing risk assessments of her home and for all types of outings. She ensures that all people in contact with children are suitable and appropriately checked.
- The childminder maintains a current paediatric first-aid certificate. This means that she has up-to-date knowledge on how to meet the needs of children in the event of an accident.
- The areas to be used for the care of children are welcoming and accessible to all. Equipment and resources provided are suitable for a range of ages, plentiful, and organised so that children can access them easily.
- The childminder understands the value of developing positive partnerships with parents and other professionals, so that information about children's care and learning is shared and their needs are well met.
- The childminder has made sufficient progress since her last inspection. She has suitably addressed the recommendations raised and is committed to the ongoing development of her provision by updating her knowledge through training.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
