Summary of key findings for parents

The provision meets requirements

- The staff understand how children learn and develop. They know how to provide a variety of fun activities for children of differing ages and abilities. They understand the necessity to take account of children's interests and needs in their planning of activities.
- The staff understand the provider's safeguarding policies and procedures and how to implement these. They complete ongoing checks and risk assessments of the school premises. These help ensure they provide a safe environment to all children.
- The staff know the importance of providing children with daily access to fresh air. They plan physical exercise and know how to promote healthy lifestyles through providing healthy snacks and regular drinks to foster children's well-being.
- The staff realise the need to work closely with the school's staff and children's parents in order to offer continuous support and complement children's learning at school through the club's activities.
- The manager keeps all required documentation available for inspection. She evaluates staff practice and supports staff training and development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the premises with a member of staff.
- The inspector took account of the views of some parents and school staff.
- The inspector had a discussion with all the staff about their safeguarding practice and partnership with parents.
- The inspector sampled activity plans and observed some older children's activities.
- The inspector held a meeting with the manager and sampled required documentation.

St Vincents After School and Holiday Club registered in 2006 on the Early Years Register and both the compulsory and voluntary parts of the Childcare Register. It runs from St Vincent Primary School. The club operates between 3pm and 5:45pm every weekday during school term time only. There are three staff employed to work with the children, including the manager, of whom two hold relevant qualifications at level 3. There were no children present in the early years age range at the time of the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
