### Summary of key findings for parents

#### The provision meets requirements

- The childminder understands the importance of working in partnership with parents to meet children's care and learning needs.
- The childminder has a wide range of resources and play materials to promote children's development across the seven areas of learning.
- The childminder demonstrates a good understanding of how to safeguard children. She has clear child protection procedures to follow should she have concerns about children's welfare.
- The childminder is aware of the importance of evaluating her practice in order to maintain continuous improvement. She attends training courses to update her childcare knowledge and to improve learning outcomes for children.
- The childminder has a good knowledge of the learning and development requirements. She understands how to observe and assess children's progress and how to plan enjoyable and challenging play opportunities.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
