Service information

Brief description of the service

This home is operated by a private provider and is registered to provide care and accommodation for up to of four young people with learning disabilities, two of whom may also have physical disabilities.

Outcome of monitoring visit

Ofsted issued two compliance notices following an inadequate inspection judgement on 7 January 2015, in respect of failure to make notifications to the regulator and absence of statutory records about young people. Ofsted will shortly carry out a full inspection to monitor compliance with these notices.

The responsible individual advised Ofsted on 30 January 2015, that the appointed manager would not be able to fulfil the role of registered manager in the medium to long term because of health problems.

Ofsted carried out a visit on 5 February to consider the adequacy of the managerial arrangements. This inspection visit finds the short term leadership and management arrangements are also unsatisfactory.

There is no skilled or experienced management in the absence of the appointed manager. Staff say the manager is not well and now works from home. The manager has not been working as shown on the rota, which does not make clear whether she is absent or on leave. There are no deputising arrangements and a senior residential care worker, without previous managerial experience or training, is in day-to-day charge of the home.

There is no reliable record of which staff work at the home on any day, including the manager and agency staff. Staffing levels are apparently satisfactory and there is a core of seven permanent residential staff in total. Basic staffing ratios are maintained by use of agency staff and allow young people to continue with their regular weeknight activities.

There is no effective staff supervision system in place. There has been no recorded supervisions since October 2014. The appointed manager has not supervised any staff and there are no staff skilled or experienced to do this in her absence. Staff do not have sufficient supervision and are not supported by the registered person to provide each child with the high quality care that they need.

Young people are relatively stable at the home. There have been no safeguarding or worrying incidents, though young people's complaints, made two weeks ago, have not yet had a response. A notification about an incident when the police were called in December has still not been notified to Ofsted formally. Staff have not used any physical interventions this year and have calmed young people by talking to them.
