## **Summary of key findings for parents**

#### The provision meets requirements

- The managers know how to observe children and plan for their next stages of development. They provide a welcoming environment, which is resourced well to provide an educational programme that covers all areas of development and complements children's existing learning.
- The managers have a good knowledge of child protection procedures. They have attended safeguarding training and understand their responsibilities to protect the welfare of children.
- The managers appropriately demonstrate how they reduce hazards and keep children safe. For example, they complete and use written risk assessments for the club, including the outdoor area.
- The managers understand the importance of working in partnership with parents and other early years professionals, in order to have a consistent approach to meet children's individual care and learning needs.
- The managers demonstrate an understanding of how regular monitoring and selfevaluation can support their drive for continuous improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

#### **Inspection activities**

- The inspector viewed the areas used by children and looked at a range of resources and equipment available for children to use.
- The inspector looked at a selection of documents, including the club's safeguarding procedures, to promote the well-being of children. Suitability checks for staff were also viewed.
- The inspector discussed with the managers how they observe children and plan for their development.
- The inspector discussed with the managers how they work in partnership with parents and other professionals to fully promote children's learning.
- The inspector discussed with the managers how they evaluate the provision and continue their professional development.
