## Summary of key findings for parents

#### The provision meets requirements

- The childminder demonstrates a clear understanding of how to safeguard children. She is aware of the appropriate procedures to follow should she have concerns about a child in her care in order to help keep children safe.
- The childminder understands the importance of working in partnership with parents, to promote continuity of care and learning for children.
- The childminder has a good knowledge of the learning and development requirements. She understands how to assess and monitor children's progress and how to provide a range of stimulating activities and experiences to support children's learning and development.
- The childminder knows how to promote children's healthy lifestyles. She plans to provide nutritious meals and regular opportunities for children to develop their physical skills.
- The childminder understands the importance of evaluating her practice in order to identify areas for her own development. She has completed the recommendations from her previous inspection. She attends regular training to develop her childcare knowledge and skills.
- The childminder has a range of suitable policies and documentation in place. She will use these to support the efficient running of her provision when caring for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector looked at the childminder's policies and documentation.
- The inspector had a tour of the premises and viewed resources.
- The inspector discussed educational programmes and teaching methods with the childminder.

The childminder registered in 2011. She lives with her young child in Dulwich within the London Borough of Southwark. The childminder uses her living room, kitchen and one bedroom for childminding. There is an enclosed garden available for outdoor play. The childminder is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. At the time of the inspection, there were no children on roll in the early years age group.
