Summary of key findings for parents

The provision meets requirements

- The provider demonstrates, through discussion, her clear understanding of the requirements of the Early Years Foundation Stage. Good systems for observing, assessing and planning for children's needs are in place.
- The provider has a good knowledge of safeguarding and the welfare requirements of the Early Years Foundation Stage. The appropriate policies and procedures are in place, for example, risk assessments to maintain a safe environment for children. Staff have a current paediatric first-aid certificate.
- The provider understands how to keep children safe. She is clear about who to report any child protection concerns to and the action to take.
- The provider provides a broad range of activities in the out of school club. This supports children to become active and engaged learners.
- The provider promotes children's good health and well-being. She demonstrates, through discussion, her understanding of managing children's behaviour and of the need to build children's self-confidence and esteem.
- The provider demonstrates a strong commitment to the improvement of the provision. She is aware of the need to work in partnership with parents and external agencies, should this be necessary, to ensure a consistent approach to children's care and education.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the provider how they intend to deliver the educational programmes for children.
- The inspector looked at documentation and a range of policies and procedures the provider will use when caring for children.
- The inspector checked evidence of the suitability and qualifications of staff, the provider's self-evaluation and improvement plans.
- The inspector undertook a tour of the premises.

Prestwich Preparatory School was registered in 2005. The out of school provision is run by Friesner Education Ltd and is linked to Friesner Nurseries in Prestwich, Manchester. The out of school provision employs five members of childcare staff. Of these, one holds an appropriate early years qualification at level 3, and there are three with Qualified Teacher Status. The out of school operates Monday to Friday, from 4pm until 5.30pm, term time only.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
