The provision meets requirements

- The childminder makes sure that her home is safe and welcoming for children. She has appropriate procedures in place to promote children's safety and welfare.
- The childminder shows a suitable understanding of how to promote children's good health and wellbeing. She understands the need to gather appropriate information from parents to meet children's individual needs.
- The childminder has an understanding of the records required for childminding.
- The childminder describes how she will provide a suitable range of activities and experiences for children. She shows an understanding of how to assess children's progress and plan activities to support their development.
- The childminder demonstrates how she will work in partnership with parents and keep them informed, including providing daily written feedback for younger children.
- The childminder shows a positive attitude to continually developing and improving the provision, for example, she attends training as required to develop her skills.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
