### Summary of key findings for parents

#### This provision is outstanding

- The quality of teaching across the provision is outstanding. Staff interactions during children's activities are excellent and contribute to children being highly motivated and fully engaged in their play and learning.
- Staff form excellent relationships with the children. They are calm, kind and sensitive to each child's individual needs. This means that even children who have recently joined feel happy, emotionally secure, and enjoy their time at the setting.
- Staff practice is exemplary and the environment is organised exceptionally well. This results in children being extremely confident and self-assured. Children display high levels of independence as they move around the provision and make choices in their play.
- Staff complete rigorous assessments and sharply focus planning on every child's needs. They frequently share this information with all staff and parents to ensure every child makes rapid progress given their starting points.
- Staff establish excellent partnerships with parents, teachers and other professionals to ensure that there is continuity in children's care and learning, and to make sure that all children's individual needs are exceptional well met.
- Staff have very high expectations of all children and are highly skilled in understanding their needs. This means they provide challenges that complement and extend their learning to the highest level.
- Inspirational leadership and management means that all staff work exceptionally well together to successfully drive improvement and achieve excellence in all areas.
- Safeguarding procedures are robust. All staff have an excellent understanding of their responsibilities to protect children from harm.

## What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

 enhance further the already excellent provision for children to use information technology equipment, and place an even stronger focus on developing younger children's understanding of keeping safe on computers.

- The inspector observed teaching and learning activities in the indoor and outdoor learning environment.
- The inspector looked at a sample of policies, children's assessment records and planning documentation.

### **Inspection findings**

# How well the early years provision meets the needs of the range of children who attend. This is outstanding

Staff have an excellent knowledge of how children learn and provide an outstanding range of learning opportunities. They focus sharply on supporting children's communication and language skills, through modelling, repetition and skilful questioning. Children benefit from well-planned focused group times where staff are highly skilled in their teaching. They recognise the different abilities of children and provide innovative and challenging opportunities which successfully supports them to make rapid progress. Children have plenty of opportunities to explore, investigate and take the lead in their learning. Staff support, facilitate and extend children's ideas. For example, children enjoy water play and whisking bubbles. This leads to the addition of sprinkles and colours, which sparks their imagination as they explore the colours and patterns they are making. Staff deployment is excellent and every opportunity is used to enrich the curriculum and promote children's learning. Children confidently ask questions, solve problems and develop their own ideas. This results in children being extremely well prepared for their move to nursery and reception class.

# The contribution of the early years provision to the well-being of children is outstanding

The strong, well established key-person system means staff support the individual needs of each child exceptionally well. Children are highly supported in their move from home to the setting as staff work extremely well with parents. Children are actively encouraged to be independent throughout routines, and choose when to have snack and play outside. This enables children to benefit from prolonged periods of uninterrupted play, which successfully supports children's high engagement in activities. Staff act as excellent role models and encourage children to be aware of each other's needs. They consistently use positive praise and reinforcement to promote good behaviour. The outdoor area is exceptionally well resourced and provides an abundance of opportunities for children to explore, create and be imaginative. Staff place a high focus on physical activities both inside and outside. They support children extremely well to take supervised measure risks as they play, giving children exceptional confidence to try new things.

# The effectiveness of the leadership and management of the early years provision is outstanding

The manager ensures all staff have an excellent understanding of the requirements. This means there is a shared approach to delivering exceptional standards across the setting. Rigorous recruitment and vetting systems ensure all people working with children are suitable to do so. High-quality supervision allows staff to continually evaluate their practice, improving their excellent teaching skills. The ongoing analysis of children's assessment information ensures that timely intervention is put in place to narrow any gaps in children's learning. Robust self-evaluation means that managers and staff very successfully monitor the setting and determine how to improve even further. Staff have identified and are already working on developing opportunities for children to use technology and develop even further their understanding of safety when using computers.

Monkeys Childcare was registered in 1997. It is situated in Monkspath Junior and Infant School in the Monkspath area of Solihull, and is managed by the schools governing body. The provision employs 31 members of childcare staff. Of these, 11 hold appropriate early years qualifications at level 3. The provision offers before and after school, wrap around and nursery care. It opens from Monday to Friday, all year round. Sessions are from 8am until 6pm. The nursery provides funded early education for three- and four-year-old children.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
