The provision meets requirements

- The provider ensures staff plan activities to meet the children's individual needs.
- The staff work together with teachers to provide continuity of care for the children. They share information so staff can progress children's learning and development further.
- The provider demonstrates how they promote positive behaviour in children, and works with parents and other agencies to support children with challenging behaviour.
- The provider has clear and concise safeguarding policies and procedures, which staff follow to safeguard children.
- The provider monitors the provision effectively and assesses areas for development. Staff attend training to develop their knowledge, which benefits the children.
- Staff promote children's health and well-being by offering balanced meals and regular exercise. This also promotes their physical development.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Little Diamonds Out of School Club (St Philip Neri) registered with Ofsted in 2003. It is registered on the Early Years Register and the compulsory and voluntary parts of the Childcare Register. The breakfast club is open 7.30am to 9am and the after school club is open 3pm to 6pm during school terms. The holiday club operates during school holidays from 7.30am to 6pm. There are 11 staff work directly with the children, the number present each session depends on numbers of children in attendance. All the staff, including the manager, hold a relevant childcare qualification to level two and above.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
