The setting meets legal requirements for early years settings

Summary of key findings for parents

The provision meets requirements

- The childminder understands how to implement the requirements of the Early Years Foundation Stage and all required documents and records are in place to support the running of the childminding setting.
- The childminder has a valid qualification in paediatric first aid so that she can deal correctly with any minor accidents or injuries to children. She minimises risks to children's safety by implementing comprehensive risk assessments for the premises and any outings.
- The childminder knows how to manage any safeguarding concerns she may have about children. She has a suitable knowledge of possible signs for concern about children's welfare.
- The childminder demonstrates a suitable knowledge of how to promote children's good health by teaching children about good nutrition and the importance of taking exercise.
- The childminder understands how to provide activities which help children to learn and develop, including those which support their learning in other settings they attend.
- The childminder understands the importance of assessing children in order to plan accurately for individual children's progress, based on their observed needs.
- The childminder recognises the importance of working in partnership with parents and other settings children attend to provide continuity for children's well-being and learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the areas of the premises used for childminding.
- Evidence of the suitability of adults living on the premises and the childminder's qualifications were checked as well as documentation the childminder will use when caring for children.
- The inspector asked the childminder about her knowledge of areas, such as safeguarding, how to support children's learning and the ways in which she evaluates her practice.

The childminder was registered in 2000. She lives in the Tyldesley area of Wigan, Greater Manchester. The childminding setting operates from 7.30 am to 9am and 3.15pm to 6pm only during school term times. In school holidays, it is open from 7.30am to 6pm.
