Summary of key findings for parents

The provision meets requirements

- Discussions and evidence suggest that the childminder has a good understanding of how children develop and learn. She knows how to promote learning for children of different ages and stages and how to use the environment and resources to support their care, learning and development.
- The childminder understands how to effectively monitor children's progress through observations and assessment, and how to use this information to plan next steps in children's learning based on their individual needs and interests.
- The childminder understands the importance of partnership working with parents, other professionals and other settings that children attend, to ensure continuity of care and learning and to fully support children's all-round development.
- The childminder is aware of the importance of helping children to adopt a healthy lifestyle. She knows to help children manage hygiene routines independently, to promote healthy eating and to ensure that children have plenty of exercise and fresh air.
- The childminder demonstrates a secure knowledge of how to safeguard the welfare of children. There are effective measures in place to keep children safe by minimising risks.
- The childminder understands how to meet children's care needs and provide for their individual requirements and preferences, to nurture their good health and well-being.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
