Summary of key findings for parents

The provision meets requirements

- The childminder understands her role in safeguarding children and promoting their welfare. She ensures that her knowledge is up to date because she has attended recent safeguarding training.
- The childminder has a suitable understanding of the Early Years Foundation Stage. Consequently, she undertakes systematic observations to promote children's learning and development, and their interests.
- The childminder offers an inclusive environment to promote children's well-being. She explains how she gets to know the children well and plans activities to meet their individual learning needs.
- The childminder explains how her sound partnerships with parents encourage children's learning at home and within her setting. She invites parents to contribute to children's ongoing assessments.
- The childminder reflects on her practice well, to develop the service she provides and promote good outcomes for children. Since registration she has attended a number of courses to benefit children's learning.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had discussions with the childminder about her knowledge in safeguarding children and how she supports children's learning and development.
- The inspector sampled documents, including policies and procedures.
- The inspector discussed the childminder's self-evaluation processes.
