Summary of key findings for parents

The provision meets requirements

- The management demonstrate how they will promote children's well-being. For example, they understand how to foster strong emotional attachments. They also demonstrate how they intend to develop strong partnership with parents, other providers and schools, and work together to meet children's learning needs.
- The management demonstrate a good knowledge of how to plan children's activities to ensure they are challenged and their learning is extended. They also demonstrate how they will positively manage children's behaviour and encourage positive relationships between children.
- The management demonstrate a strong awareness of how to promote children's learning about a healthy lifestyle by providing a choice of healthy snacks. They also demonstrate a good understanding of how to provide a range of exciting activities to promote children's physical development.
- The management show a good awareness of how to keep children safe through robust risk assessments both on and off the premises. They also demonstrate how they will promote children health and well-being by maintaining records of any accidents and any medication administered.
- The management demonstrate their understanding of how to recognise the possible signs of abuse or neglect in children and they know how to respond quickly and appropriately to ensure children's safety.
- The management demonstrate their awareness of the need to undertake self-evaluation to identify strengths and any areas for further improvement that will benefit the children attending. They have met all the actions raised at the last inspection.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector and manager toured the areas of the premises where childcare is to be provided.
- The inspector and the manager discussed and looked at toys, books, resources and equipment that the provision intend to use.
- The inspector discussed with the manager how she intends to deliver the educational programme for children.
- The inspector looked at policies and documents the manager will use when caring for children and discussed self-evaluation and improvement plans.
- The inspector checked evidence of suitability and training of the manager and suitability of other childcare staff.
- The inspector took account of the views of older children attending the setting and a range of recorded comments from parents.

Hateley Heath Out of School Club opened in 1997 and is one of eight childcare provisions managed by the provider. The club employs four members of childcare staff, three of whom hold appropriate early years qualifications at level 3. One holds a level 6 qualification in sports science. The club provides an out of school club and an open access play centre. The out of school club operates from 2.30pm to 6pm Monday to Friday, during term time and from 8am to 6pm during school holidays. The open-access provision for older children operates from 3.15pm to 6.15pm Monday to Friday, during term time. It is also open from 12noon to 3pm during school holidays.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
