# **Summary of key findings for parents**

#### The provision does not meet requirements

- The childminder does not demonstrate a secure knowledge and understanding of the learning and development requirements and the seven areas of learning. This limits the effectiveness of teaching and learning.
- The childminder does not demonstrate a robust knowledge of how to monitor and assess children's progress in each area of learning, including the requirement to undertake a progress check for children aged between two and three years. This has an impact on her ability to carry out effective assessments and planning to meet each child's individual needs.
- The childminder demonstrates a strong understanding of how to promote children's emotional well-being. She offers gradual settling-in processes and develops positive bonds with children.
- The childminder maintains a clean, safe and secure home to ensure children's welfare. She provides a suitable variety of resources and activities, to interest and engage children of all ages.
- The childminder demonstrates a good understanding of how to promote children's understanding of a healthy lifestyle, through regular exercise and healthy food choices.
- The childminder demonstrates that she is able to work in close partnership with parents and carers in order to support children's individual care needs.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

## To meet the requirements of the Early Years Foundation Stage the provider must:

- gain knowledge and understanding of the learning and development requirements, particularly the seven areas of learning, and how to implement them in practice, to ensure that teaching is effective in promoting children's learning and development
- develop a robust knowledge and understanding of how to monitor and assess children's progress, including how to complete the progress check for children aged between two and three years, in order to accurately assess children's stages of development against expected levels.

### **Inspection activities**

- The inspector discussed with the childminder how she intends to deliver the educational programmes for children and undertake observation, assessment and planning.
- The inspector looked at policies and documents the childminder will use when caring for children.
- The inspector viewed the childminder's training certificates and evidence of her suitability.
- The inspector viewed areas to be used for the care of children along with furniture, equipment and toys that are to be used for childminding.
