Summary of key findings for parents

The provision meets requirements

- The childminder demonstrates that she is aware of the Early Years Foundation Stage learning and development, and assessment requirements. She identifies guidance documents that she will consult to aid her in ensuring that children are challenged successfully so that they make progress.
- The childminder provides suitable resources that meet the needs of children at different stages of development.
- The childminder successfully identifies and minimises risks in her home. She demonstrates a sound knowledge of what would cause her concern and her responsibilities to protect children from abuse and neglect.
- Detail on the service provided for parents and children is identified in a range of policies and procedures. Documentation that parents are initially asked to complete includes clear detail on children's care needs.
- The childminder explains that a gradual introduction into her care addresses the emotional security of early years children.
- The childminder seeks advice from representatives of the local authority and from other childminders, in order to review and improve her provision.
- The childminder is able to address children's welfare needs because she keeps her firstaid and safeguarding knowledge up to date.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
