# Summary of key findings for parents

### The provision does not meet requirements

The childminder has attended safeguarding training and is able to recognise signs of concern. However, she is not familiar with the procedures for reporting concerns to help protect children from harm, As a result, she is not able to fully protect children's welfare. This is also a breach of the Childcare Register requirements.

Previous inspection:

- The childminder has limited knowledge of the learning and development requirements. She is unable to plan for children's individual needs and the next steps in their learning, track their development or complete observational assessments to help promote their progress.
- There are weak partnerships with parents. Although the childminder provides daily feedback to parents, she is unaware of how to involve them in their children's learning. She does not work with other professionals to provide additional support for children.
- The childminder uses risk assessments to help limit hazards to children to help keep them safe. However, she does not have an evacuation plan as required, which means that children are not aware of what to do in the event of a fire or other emergency,
- The childminder uses self-evaluation tools to identify strengths and address some weaknesses in her practice, with the view of making improvements. However, she has not identified gaps in her knowledge and the weaknesses in her practice.
- The childminder offers resources to stimulate children's learning, indoors and outside.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

# What the setting needs to do to improve further

### To meet the requirements of the Early Years Foundation Stage the provider must:

- develop knowledge of the seven areas of learning of the Early Years Foundation Stage and plan activities and learning experiences that incorporate children's interests, offer challenge and meet their individual needs
- develop knowledge of and carry out the required progress check for each two-year-old child and provide their parents with a short written summary of the child's development in the prime areas of learning
- monitor children's achievements and assess their progress to promote the next steps in their learning and development effectively
- have regard to the Government's statutory guidance 'Working Together to Safeguard Children' in order that any concerns about children's safety or welfare are notified to agencies with statutory responsibilities without delay
- take reasonable steps to ensure the safety of children in case of fire or any other emergency by making sure all children know and understand the evacuation procedure

#### To meet the requirements of the Childcare Register the provider must:

- become familiar with the appropriate procedures for reporting safeguarding concerns, liaising with the local Safeguarding Board as and when necessary (compulsory childcare register)
- become familiar with the appropriate procedures for reporting safeguarding concerns, liaising with the local Safeguarding Board as and when necessary (voluntary childcare register).

## **Inspection activities**

- The inspector sampled documents, such as the childminder's policies and the information she keeps about the children.
- The inspector discussed with the childminder how she will deliver the educational programmes for children.
- The inspector held a discussion with childminder regarding her role and responsibilities in safeguarding children.
