The provision meets requirements

- The childminder understands how to effectively monitor her practice and target areas for improvement. She knows how to track children's progress through observation and assessment, and how to use this information to plan next steps in children's learning.
- The childminder understands how to effectively monitor children's progress through observation and assessment, and how to use this information to plan next steps in children's learning.
- The childminder understands the importance of working in partnership with parents, other professionals and other settings that children attend, to ensure continuity of care and learning, and to fully support children's all-round development.
- The childminder is aware of the importance of helping children to adopt a healthy lifestyle. She knows how to help children manage positive hygiene routines independently, to promote healthy eating and to ensure that children have plenty of exercise and fresh air.
- The childminder demonstrates a secure knowledge of how to implement the requirements of the Early Years Foundation Stage. She has a good understanding of how to safeguard the welfare of children. There are effective measures in place to keep children safe by minimising risks.
- The childminder understands how to meet children's care needs and provide for their individual requirements and preferences, to nurture their good health and well-being.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector viewed the areas of the premises and the garden used for childminding.
- The inspector discussed with the childminder how she intends to deliver educational programmes for children.
- The inspector looked at documentation and a selection of policies and procedures, including risk assessments, certificates and evidence of the suitability of the childminder.
