Summary of key findings for parents

The provision meets requirements

- The club staff know how to provide children with a variety of appropriate indoor and outdoor play activities. Staff understand how to provide resources to help children make independent choices, so children can follow their interests in play.
- Staff understand how to manage children's behaviour in a positive way according to their individual stages of development.
- The provider ensures that staff understand the safeguarding and welfare requirements and how to implement these. Staff understand how to maintain children's good health, and promote their safety and welfare. They know the club's policies and procedures. Staff recognise the importance of undertaking checks to maintain a safe environment for children.
- The provider has clear vetting and recruitment procedures to check that persons working with children are suitable to do so. The manager monitors the ongoing suitability of staff through supervision sessions. They take suitable steps to promote inclusion and work in partnership with others.
- The manager and staff attend appropriate training to update their childcare knowledge and awareness. They reflect on their effectiveness to improve the provision.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector checked required records and documentation.
- The inspector checked safety of the premises and suitability of play resources.

Pleasure & Leisure Out of School Club registered in 2000. It operates at Antony Church of England School at Antony near Torpoint. The club opens five days a week during school term times. Sessions are from 7.30am to 8.45am and from 3.15pm to 6pm. There are four staff who work with the children, all of whom have a relevant early years and/or playwork qualifications at level 3. There were no children in the early years age range present at the time of inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
