The manager has worked hard to find ways to monitor the planning and assessment so that they are consistent and precise. This improvement has enabled her to identify gaps in children's learning and work with the team to find ways of closing the gaps. Staff now complete regular and precise assessments of children and use this information to plan stimulating activities. Activities are now more purposeful and enable children to develop useful skills for the next stage in their learning.
