Summary of key findings for parents

The provision meets requirements

- The manager demonstrates through discussion a good understanding of the requirements of the Early Years Foundation Stage, to promote children's welfare and learning needs.
- The manager demonstrates through discussion and documentation how to promote children's learning and development through observation, planning a wide range of learning experiences, and working in partnership with parents and other professionals.
- The manager demonstrates an appropriate understanding of promoting children's well-being and welfare. She has a good secure awareness of how to promote their good health.
- All staff demonstrate a strong understanding of the safeguarding procedures and the correct procedures to follow should there be a concern about a child's welfare.
- The organisation management team and the setting staff work closely together to improve the quality of the provision. They explore feedback from parents, use varied systems to identify strengths and weaknesses, and welcome the support of the local authority. The management team supervise staff and support them to attend relevant training, to improve further their knowledge and skills.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with management and staff, to explore their understanding of the learning and development requirements, and the safeguarding and welfare requirements.
- The inspector looked at a sample of the play materials for children, and the areas used by the children.
- The inspector looked at a sample of required records that the manager maintains about children attending, and at required records, policies and procedures they share with the parents.
- The inspector looked at the planning of activities and records maintained about children's developmental progress.
- The inspector spoke to management about the use of self-evaluation to maintain continuous improvement, including addressing previous recommendations.

St Anthony's Catholic Primary After School Club registered in 2011, and is part of a group of out-of-school care provisions operated by Forest YMCA of East London. The setting operates from St. Anthony's RC Primary School in Woodford Green, within the London Borough of Redbridge. The setting operates each weekday from 3.15pm to 6pm, during term time. The club also offers care to children over five years to 11 years. The club employs two members of staff, who both hold early years qualifications at Level 3. There were no children in the early years age range present at the time of the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
