Summary of key findings for parents

The provision meets requirements

- Staff have good understanding of the requirements of the Early Years Foundation Stage. They are experienced at providing a stimulating range of resources and planned activities that help to challenge children, based on their individual interests.
- The manager and staff know how to promote an inclusive environment where children's individual backgrounds are respected and valued. They plan well to help children learn about people from other cultures, backgrounds and abilities through displays, resources and planned activities.
- Staff make good use of secure entry systems. They work in partnership with other organisations using the community centre, to monitor the premises. They know how to complete risk assessments that help to ensure that children are safe.
- The manager as designated person with responsibility for safeguarding has up-to-date knowledge of safeguarding practice and procedures. She is able to support staff, who understand reporting procedures and the indicators that would cause concern, so that they can confidently promote children's welfare and well-being.
- The manager has developed good partnerships with parents and other professionals at local schools. Staff know how to share information effectively to enhance children's learning at home.
- The manager uses an effective self-evaluation process to identify strengths and address weaknesses. She invites the views of children, parents and staff to drive improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed the service provided by the holiday play scheme with the manager.
- The inspector viewed the premises to be used for the holiday play scheme.
- The inspector talked to the manager about daily routines and how the staff team intend to meet children's individual care needs.
- The inspector reviewed the setting's policies and documentation, including those for safeguarding.
