- Staff quickly identify children with specific needs and parents are fully involved in the plans for these children.
- The well-qualified team has significant knowledge of how children learn. Their enthusiasm and professionalism has developed the pre-school and activities provided.
- Children are making rapid progress through an exciting mix of activities.
- Carefully planned outdoor experiences give excellent learning opportunities that reflect the children's interests.

continue to identify the changing needs of the provision, including ways to add children's views to the self-evaluation process.

### **Inspection findings**

# How well the early years provision meets the needs of the range of children who attend. This is outstanding

The staff provide a rich range of activities that capture children's attention. Staff plan weekly to ensure they are constantly following the children's interests. The effective balance of free choice with adult-led play ensures the children are able to learn at their own pace and level. Children receive constant praise for their achievements and the adults value all contributions from the children. Consequently, the children learn to respect each other's contributions. Staff give clear and precise instructions that children understand. Highly motivated staff guide the children's play and extend their learning. They capitalise on unexpected chances for learning, stemming from children's curiosity. For example, children found an owl skeleton in the forest and told stories about the owl and made their own skeletons from sticks and mud. Children gain the skills and attitudes required for school.

# The contribution of the early years provision to the well-being of children is outstanding

All staff are highly focused on the well-being of the children. Staff visit children at home before they start at the pre-school, developing effective partnerships with parents. Staff use their excellent knowledge of child development to recognise where children need additional help and work closely with outside agencies to obtain this. All staff have an comprehensive understanding of safeguarding and keep children safe. Staff meet regularly with children for whom they take special responsibility, which helps them feel happy, safe and secure. Parents are encouraged to become involved with the children's interests. Children take responsibility for their own safety by learning about boundaries and danger. For example, they understand the meanings of different flags during Forest School. Partnerships with the local school help prepare children for the move with visits from the teachers.

# The effectiveness of the leadership and management of the early years provision is outstanding

The manager is an exemplary leader with excellent knowledge of requirements who oversees the implementation of these to an exceptionally high standard. Staff meet children's physical needs extremely well. The manager constantly strives to improve the pre-school. She looks for solutions to problems and fully engages her staff, committee and parents in this process. This 'can do' approach has resulted in the whole pre-school having a very clear vision of where the pre-school should develop. Regular meetings as a group and one-to-ones with staff ensure the manager knows her staff extremely well. In return, staff feel secure to discuss their ideas. Staff are encouraged to update their training regularly. They are fully involved in pre-school life, for instance in leading group times. However, children's views are not included in evaluation documents.

Horfield Welly Pre-School opened in1992 and registered with Ofsted in 2001. It is located in Horfield. The pre-school opens four mornings each week from Tuesdays to Fridays during term time. Sessions are from 9.15am to 1pm. There is a team of nine staff; all but one hold recognised early years qualifications. One member of staff holds a teaching qualification. The pre-school receives funding to provide some free early education to children aged three and four years.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
