Summary of key findings for parents

The provision meets requirements

- The childminder is able to plan a range of activities for different groups of children according to their individual next steps and interests. This helps them progress and develop within the early learning goals.
- The childminder has a range of accessible resources to support children's interests and free choices.
- The childminder understands how to promote children's well-being by being a positive role model to support their good behaviour and helping them learn how to keep themselves safe and healthy.
- The childminder has a suitable knowledge of how to safeguard children to help protect them from harm and assess risks in her home to keep children safe.
- The childminder is able to evaluate her practice to drive improvement to raise standards and outcomes for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed and questioned practices and routines with the childminder.
- The inspector looked at the childminder's documentation, including the policies she has regard to when childminding.
- The inspector viewed the areas of the home used for childminding.

The childminder registered in March 2008. She lives with her adult son in a flat in a secure block with a concierge in the London Borough of Lambeth, close to Loughborough Park. There were no children present at the time of the inspection.
