Summary of key findings for parents

The provision meets requirements

- The childminder has a good understanding of the Early Years Foundation Stage. She understands her responsibilities and meets the requirements. She knows to inform Ofsted of any significant events.
- The childminder has a good range of interesting play resources, including, books, dolls, construction and board games to promote children's learning and development.
- The childminder demonstrated her knowledge of safeguarding children. She knows how to identify and report any concerns she may have to ensure their well-being.
- The childminder discussed how she evaluates her practice, and drives improvement. For example, she monitors children's progress, attends further training and values feedback from parents, which benefits children.
- The childminder explained how she informs parents about their child's progress and future development so they work together well.
- The childminder provides children with resources promoting differences, so that they learn, understand and respect others.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector discussed with the childminder her knowledge of safeguarding and promoting children's welfare and the learning and development requirements.
- The inspector looked at areas of house used for childminding.
- The inspector reviewed the required documentation including training certificates, policies and children's records with the childminder.
