## Summary of key findings for parents

### The provision does not meet requirements

- Some staff have a poor knowledge of how to respond to child protection concerns. They do not know how to implement appropriate procedures, such as making referrals to relevant agencies. Consequently, children are not adequately safeguarded.
- The organisation of records does not ensure all information and required documentation are readily available and efficiently used to manage the club.
- Staff understand how to support children's physical and emotional well-being. They understand how to support children to be happy and confident in making choices in their play. They provide an environment that is welcoming, safe and stimulating.
- Staff demonstrate an understanding of how providing a range of resources and learning opportunities supports children's learning and development needs.
- The managers demonstrate an understanding of how regular monitoring and self-evaluation can support their drive for continuous improvement.
- Staff have established positive links between the club and the host school. This is in order to support children to make progress in their learning and development.
- Staff understand the importance of partnership working with parents to ensure they are able to meet the individual needs of all children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

## What the setting needs to do to improve further

### To meet the requirements of the Early Years Foundation Stage the provider must:

- train all staff to understand and implement an effective procedure to safeguard children, this should be in line with the guidance and procedures of the relevant Local Safeguarding Children Board
- improve the organisation and storage of records to ensure they are easily assessable and readily available, to ensure the safe and efficient management of the setting.

### To meet the requirements of the Childcare Register the provider must:

- train all staff on the written statement of procedures to be followed to safeguard children from abuse or neglect (compulsory part of the Childcare Register)
- train all staff on the written statement of procedures to be followed to safeguard children from abuse or neglect (compulsory part of the Childcare Register).

## Inspection activities

- The inspector had a tour of the out-of-school facilities, and observed activities indoors and outdoors.
- The inspector checked evidence of the suitability and qualifications of the staff working with children.
- The inspector took account of the views of parents spoken to on the day of the inspection.
- The inspector checked safety records, the provider's evidence of self-evaluation and a range of other documentation.
- The inspector held meetings with the managers of the provision and spoke to staff throughout the inspection, when appropriate.

Gilthill Kids Club registered in 2003. It is one of a number of similar schemes provided by JPAC Ltd. There are five members of staff, four of whom have appropriate early years qualifications. The club is open to children who attend Gilthill Primary School and operates from 3.30pm until 6pm, during school term times only.
