Summary of key findings for parents

The provision meets requirements

- The childminder plans activities to give children an enjoyable time and to meet their individual needs and abilities. She understands that children are stimulated and will engage in activities in which they are interested.
- Children benefit from going on plenty of outings. They learn about the wider world they live in as they explore animals and plants at the farm, and various parks and museums.
- The childminder follows suitable measures to promote children's ongoing safety in the indoor and outdoor environments. She does daily safety checks so that children play in a safe environment.
- The childminder encourages children to develop appropriate awareness about good hygiene practice to support their health and well-being.
- The childminder has a consistent approach to behaviour management. She teaches children clear boundaries so they understand the rules to follow.
- The childminder is aware of the importance of monitoring the quality of her provision. She takes children's views and parents' feedback into account to shape her service.
- The childminder has met the recommendations from the previous inspection and is working to secure further training to develop her observation and planning skills. This demonstrates capacity for continuous improvement.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector looked at the resources available for children's use indoors.
- The inspector held discussions with the childminder about planning, and child protection and safeguarding issues.
- The inspector looked at children's records.
- The inspector viewed relevant documentation, including the childminder's policies and procedures.
