Summary of key findings for parents

This provision is good

- Staff form exceptional relationships with the children they care for. This means that they meet children's individual needs extremely well and children form strong attachments with the staff.
- Excellent partnerships between parents and staff ensure that parents remain well informed about their child's developmental progress. Parents have regular meetings and opportunities to read assessments of their children's learning journey and next steps.
- Children have access to a wide variety of resources, which the staff rotate to meet their interests and stimulate their learning.
- The manager has a detailed set of meetings with the parents. She explains the policies and procedures and how they develop the children's learning and development.
- Staff ensure that children follow highly effective hygiene procedures. All children understand that they need to wash their hands before eating and do so independently. Some children are able to explain exactly why they need to wash their hands.
- Children enjoy healthy snacks and learn about healthy eating through discussions at mealtimes, books and growing vegetables in the garden.
- Staff have a secure knowledge of safeguarding and child protection issues. They regularly attend training to update their knowledge. Therefore, children remain safe.

It is not yet outstanding because:

■ At times, staff do not always consistently extend and challenge children's learning in the outdoor area. This is because staff rotate frequently between indoors and outdoors which does not enable them to become fully engrossed in children's play experiences.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

review the opportunities for staff in the outdoor area to consistently extend and challenge the children's learning.

Inspection activities

- The inspector observed activities and the quality of teaching inside and outside.
- The inspector held a meeting with the manager of the provision.
- The inspector sampled a range of documentation, including children's development records, the self-evaluation form and key policies.
- The inspector took account of the parents' views through discussions.
- The inspector spoke to members of staff and children at appropriate times during the inspection.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is good

The quality of teaching is good. Staff plan interesting activities, for example, making different types of messy play for the children to explore, enjoy and talk about. These motivate the children's interests and help them to learn. Staff use observations and assessments to plan next steps activities to help children make good progress from their starting point. Staff are good at promoting and extending the children's mathematical language and knowledge. For example, at the snack table the children decided whether to cut their toast into rectangles or squares. Children enjoy reading books with the staff and the staff extend their early reading skills by asking the children to predict the stories or discuss details in the pictures. Staff ensure that children have plenty of opportunities to develop their early writing skills. For example, in the fancy dress shop, children write receipts for the clothes they are wearing.

The contribution of the early years provision to the well-being of children is outstanding

Staff have excellent links with the local schools, and teachers visit to meet their new children. The key person makes a book for the parents and teachers containing the child's achievements. This ensures that teachers have an excellent understanding of the children's personalities and stages of development, which promotes a smooth move on to school. Staff are exceptional at developing the children's independence and encouraging them to manage risks. Staff help the children to use scissors safely and navigate on the bikes. They encourage children to independently self-select their own activities and butter their own toast. All staff work very closely with parents and other professionals to support and promote each child's emotional and learning needs. Staff work in small groups to give children extra support to develop their confidence and abilities. For example, staff use bean bags to give children extra support to develop their large muscle skills.

The effectiveness of the leadership and management of the early years provision is good

The manager is motivated and regularly encourages staff and parents to review the setting's practice. She has a very comprehensive self-evaluation form, which she prepares with the assistance of staff and parents. The manager has a thorough understanding of the strengths and areas for development, to identify how the practice can improve further. She has good arrangements for the recruitment of new staff and for regular supervision meetings to support and extend staff performance. The manager regularly monitors and analyses children's progress to ensure that all children make good progress in their learning and identify areas where children are developing more slowly. For example, boys are making less progress in the area of expressive arts and design so staff plan to develop activities that will engage and develop the boys' skills.

St Andrew's Playgroup registered in 2007. It operates in Whitstable, Kent. The playgroup is open on Mondays and Thursdays from 9.15am to 2.30pm, and on Tuesdays, Wednesdays and Fridays from 9.15am to 11.45am, during term time. There are seven staff, including one of the owners, who work with the children. Five of the staff hold relevant childcare qualifications at level 3. Two members of staff hold early years qualifications at level 6. The playgroup is in receipt of funding for the provision of free early years education for two-, three-, and four- year olds.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
