## Summary of key findings for parents

### This provision requires improvement. It is not yet good because:

- The quality of teaching is variable, which means staff do not fully promote children's learning and development, particularly during adult-led activities.
- Staff do not consistently promote children's sense of security and well-being because the key-person system is ineffective. As a result, some children are not able to form secure attachments and be entirely confident to explore their surroundings.
- Although the provider has developed methods for planning and assessing children's progress, not all staff fully embed this process to help them identify and plan children's next steps in learning.

## It has the following strengths

- The provider has made many improvements since her last inspection. She has developed a clear action plan to help focus on ways to further improve the provision. This has been positively accepted by the staff team and has enhanced the outcomes for children attending.
- Staff encourage healthy lifestyles by ensuring children have nutritionally healthy snacks and opportunities to access daily fresh air and physical exercise. Children are also learning to independently manage their personal care needs.
- The provider promotes children's welfare by implementing effective systems for recruiting suitable staff and ensuring staff hold relevant qualifications.
- Staff hold current paediatric first-aid certificates. They have a sufficient understanding of their responsibilities for safeguarding children and follow the nursery's safeguarding policy, including whom to contact for additional support, if necessary.

## What the setting needs to do to improve further

#### To meet the requirements of the Early Years Foundation Stage the provider must:

- ensure the quality of teaching is consistent by encouraging all children to contribute during adult-led activities and allowing them to direct their own play to help children make effective progress
- improve the key-person system to meet children's individual care and learning needs and to build effective relationships, to help them settle and feel secure, and share this information with parents.

### To further improve the quality of the early years provision the provider should:

strengthen the assessment arrangements further in order to regularly monitor children's progress and ensure all staff use this information effectively to plan children's next steps in learning.

#### **Inspection activities**

- The inspector observed activities in all group rooms and the outside play space.
- The inspector spoke to members of staff and children at appropriate times during the inspection and held meetings with the provider.
- The inspector carried out a joint observation with the provider in the toddler and preschool rooms.
- The inspector took account of the views of parents spoken to on the day of the inspection.
- The inspector looked at children's records, planning documentation, staff suitability records, and policies and procedures.

## **Inspection findings**

## How well the early years provision meets the needs of the range of children who attend. This requires improvement

Staff do not always use planning effectively to identify children's next steps and the quality of teaching is inconsistent at times. This is because some staff do not always notice when less confident children need further support or encouragement during adult-led activities. Nevertheless, staff has developed their knowledge of the Early Years Foundation Stage following their last inspection, due to the input from outside agencies. Therefore, children are making adequate progress. Staff provide children with suitable experiences to enhance their learning. Children visit the outdoor space in small groups to develop their social skills and staff ensure the environment is inclusive, by considering children's individual interests. Children enjoy using the large sheet as a canvas with paint brushes to develop their markmaking skills. Staff generally present resources sufficiently to engage children, especially during child-initiated play, although some adults spend time directing children's play at times. The babies and toddlers play confidently and follow directions from staff well. This shows that children are suitably gaining some skills to prepare them for school.

## The contribution of the early years provision to the well-being of children requires improvement

Staff interact with children in a warm and caring manner and adequately promote their emotional well-being. However, the key-person system is not robust to ensure children's individual needs are sensitively addressed, particularly during changes to their daily routine. Additionally, parents are not always sure who their child's key person is, but feel they can talk to any of the staff team. Despite this, children's behaviour is good and staff are developing suitable behaviour management strategies, which help children feel valued and respected. Overall, staff support the engagement of parents, by sharing daily information about their children's learning. Parents are complimentary about the setting and feel they can talk to the staff at any time about their child's progress.

## The effectiveness of the leadership and management of the early years provision requires improvement

The nursery provision is managed adequately by committed leaders, therefore children benefit from being cared for in a safe environment. However, children's progress is hindered at times due to the lack of effective monitoring of teaching practice and the organisation of the key-person system. This results in children not consistently having their individual learning and care needs met. Nevertheless, the manager has developed the system for performance management. Consequently, staff now receive regular supervisions to ensure they reflect on their practice and raise the quality of teaching. Although, this area still needs further input due to the weaknesses identified, staff are beginning to make changes to improve outcomes for children.

Alpha Kids Day Nursery registered in 2013. The nursery is located in the Clapton area, in the London Borough of Hackney. The nursery is open from 7.30am to 6pm, for 51 weeks of the year. The provider receives funding for free early education for children aged two, three and four years. The provider employs eight staff. All staff hold appropriate qualifications, including six staff at level 3 and one staff at level 2. The provider has achieved Qualified Teacher Status.
