This inspection

This home was judged adequate at the last full inspection. At this interim inspection Ofsted judge that it has **sustained effectiveness**.

It is less than two months since the last full inspection of the home. The manager's application for registration has yet to be finalised by Ofsted. Since the last inspection the service has continued to operate two weekends per month, plus a midweek night on two additional occasions per month. The group of young people who access the service remain the same. Similarly, the staff team has remained mainly consistent, although all the staff employed also work elsewhere in the organisation.

Five requirements were made at the last full inspection in January 2015. The manager has taken swift action to ensure that these have all been addressed. For example, the behaviour management policy has been reviewed and now makes it clear to staff what disciplinary methods must not be used in the home; risk assessments now inform the decision about young people engaging in an activity outside of the setting; clear records illustrate the decision making process in the event of safeguarding concerns; and a comprehensive location risk assessment confirms that the service is appropriately located. Good progress has been made in a limited period of time, demonstrating the manager's enthusiasm to improve the quality of care afforded to young people.

In addition, the Statement of Purpose has been updated, although a copy has not yet been forwarded to Ofsted, as required. This document is comprehensive. However, the home has not been operating in accordance with this. Staff are not receiving supervision at the frequency outlined in this and some staff have not received formal supervision in the last four months. In addition, separate permissions have not been sought from young people's parents or social workers for the use of electronic listening devices in young people's bedrooms. Consequently, the service is not functioning as outlined to parents and commissioners at the onset of their short break arrangements.

The children's guide to the service has also been updated. This now includes a large number of photographs of the centre. This is particularly valuable for young people who struggle to communicate verbally, as it gives them a better understanding about the centre that they will be staying in. This also includes photographs of the staff that will be caring for them. Many of whom are known to the young people as a result of them accessing other support services through Carlisle Mencap. This helps prepare young people for their stay.

Four recommendations were also made at the last inspection. Action has been taken to address two of these. The home's missing from home procedure has been reviewed and young people have been involved in a fire drill since the last inspection. Both of these measures improve young people's safety and security. However, staff still do not benefit from a dedicated handover period to ensure the essential exchange of information about young people; and problems remain in relation to the frequency of supervision, as highlighted above. Hence, the later has been escalated to a requirement at this inspection.

Errors in medication records were evident at this inspection. For example, medication had been returned to a young person's family but records indicated that it remained on the premises. In addition, one young person's medication had been counted incorrectly, so the balance did not tally when it was returned at the conclusion of the young person's stay. Furthermore, these issues which were identified during the inspection had not been identified prior to this. Such errors indicate that the current system is not sufficiently robust to ensure the health and well-being of young people during their stay. Staff did take immediate action to verify the situation during the inspection.

Young people continue to enjoy their short break stays; while their parents benefit from an essential period of respite. Young people continue to engage positively in a range of activities and learn new skills during their time here. Staff ask young people for feedback at the conclusion of their stay. Recent comments include, 'I enjoyed it here', 'I like playing with the other children' and 'I like using the computers and doing baking'.

Information about this children's home

This four bedded children's home is run by a registered charity and provides short breaks care for children and young people with physical and/or learning disabilities.
