Monitoring for provision judged as inadequate

An Ofsted inspector, Linda du Preez, monitored your provision on 08/04/2015 following your inspection where the provision was judged to be inadequate.

Outcome of monitoring

As a result of our inspection on 28/01/2015, we sent you a welfare requirements notice. If you were set actions at the inspection, or as a result of our subsequent monitoring or investigations, these are included at the end of this letter.

At the visit on 8 April 2015, the inspector found that managers have worked hard to drive improvements across the nursery. Staff supervision arrangements are now well organised and effective. All staff have attended meetings and training. Consequently, they are enthusiastic and confident about how they can support children's learning and development. The programmes for personal social and emotional development are much improved. There is a stronger focus on the role of the key person and this enables staff to know children and therefore meet their specific needs. Managers have clear arrangements in place to monitor the educational programmes. Planning is now focussed on each individual child's interests and progress. Staff working with the youngest children focus on their early stages of development. The newly decorated baby room is inviting and cosy. The environment for the younger children provides resources and activities, which are age appropriate. These improvements have enhanced the quality of the provision.

Having considered all the evidence, the inspector is of the opinion that the setting has taken prompt and effective action to address the points for improvement.

Next steps

The next step will be a full inspection.
