This provision is outstanding

- Children have an extremely fun and enjoyable day filled with exciting activities.
- Staff skilfully tailor activities to suit the varying ages, needs and abilities of the children.
- All staff are highly nurturing and foster excellent relationships with the children.
- Useful information about the club and activities is readily available and easily accessible to parents.
- Staff consistently promote the safety and well-being of all children by emphasising the importance of healthy lifestyles.
- Staff promote children's independence superbly by positively praising and encouraging them to complete activities by trying their best.
- The key-person system is securely in place. All staff actively ensure that all children's needs are met, and that they are happy and having fun.
- Staff regularly attend courses to update their knowledge on working with children and how to keep children safe from harm. This leads to first class care and play opportunities.
- Children benefit highly from engaging in enjoyable activities that have been inspired by the courses that staff attend.
- Staff aspire to achieve goals that are set for them on a monthly and annual basis. As a result, all staff are highly motivated and enthusiastic in their roles.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

enhance the availability of alternative resources for young children who do not want to participate in set group activities.

- The inspector spoke to and engaged with staff and children at appropriate times during the inspection.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is outstanding

Staff provide a wide variety of fun and exciting activities for the children throughout the day. Staff ensure that all children are included; for example, children undertook creative activities indoors and staff regularly engaged with the youngest children in the room. The activities are excellently tailored to suit all children and as a result they are highly motivated and eager to participate. Staff consistently encourage children to try different activities and to do their best. This increases their independence and inspires self-confidence. Children are not made to participate in activities that they do not wish to participate in. They happily occupy themselves using alternative resources, but the range of activities to choose from is not as extensive as at other times.

The contribution of the early years provision to the well-being of children is outstanding

Staff are exceptionally skilled at making sure that all children are happy, safe and secure at all times. Staff console children who are upset by being kind and nurturing. They provide regular opportunities to boost children's self-esteem and confidence. For example, the children were all made captains to lead teams of older children in a mini Olympics activity. Staff are highly proactive and take every opportunity to teach children good values, such as respect and being kind to others. They constantly promote children's health and well-being by emphasising the importance of safety, regularly drinking water, undertaking regular exercise and keeping clean. As a result, children are well-behaved, interact extremely well with each other and engage in excellent hygiene routines. All children are aware of the behavioural expectations and act accordingly.

The effectiveness of the leadership and management of the early years provision is outstanding

Staff highly value the importance of keeping children safe and reinforce this when explaining activities to the children. They also complete daily risk assessments to ensure the safety and suitability of the environment and all activities. Staff are fully aware of the procedures to be followed if a child is harmed in any way. Staff contact parents immediately in the case of any accidents or incidents and are well-trained to deal with these situations. Staff undergo annual appraisals and aspire to achieve the targets set for them. As a result, staff are highly motivated and eager to improve their practice. Children benefit from staff regularly attending training and courses, as ideas and information gained are used to create fun and exciting activities. Management have a robust self-evaluation system that they use to realistically identify strengths and weaknesses. They take into account the ideas and opinions of parents through the provision of regular parent questionnaires.
