Summary of key findings for parents

The provision meets requirements

- The staff understand how children learn and develop. They know how to provide a variety of fun activities for children of differing ages and abilities. They understand the need to take account of children's interests and needs in their planning of activities.
- The staff understand the provider's safeguarding policies and procedures and how to implement these. They complete ongoing checks and risk assessments of the premises and outings. This helps to ensure they provide a safe environment for all children.
- The management explains how staff build positive relationships with parents. Staff discuss children's needs with parents when they first start and share information on a daily basis. Parents of older children are very positive about the provision and comment that children are happy and enjoy their activities.
- The staff know the importance of providing children with daily opportunities for fresh air and energetic play. For example, they plan sports activities and fun trips to the park. They also know how to promote healthy lifestyles through providing children with healthy snacks and regular drinks, to foster their well-being.
- The managers are organised and ensure policies and procedures are shared, updated and implemented consistently. They evaluate their practice, promote staff training and are committed to continuous development, to improve outcomes for children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector had a tour of the premises with one of the managers.
- The inspector took account of the views of parents.
- The inspector sampled activity plans and observed some older children's activities.
- The inspector had a discussion with the staff about their safeguarding practices and the partnerships with parents.
- The inspector held a meeting with management and sampled required documentation.

BIS Playscheme registered in 2007. It is situated in the London Borough of Westminster. It operates each weekday, from 8.30am to 6pm, during all school holidays. The provider employs 38 staff, 22 of whom hold relevant qualifications. There are five staff who hold Qualified Teacher Status. There were no children present in the early years age range at the time of the inspection.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register.
