## Summary of key findings for parents

### The provision meets requirements

- The childminder demonstrates a good knowledge and understanding of the learning and development requirements. She holds a level 3 qualification in early years and has a sound knowledge of how to promote children's learning and development. She has fully considered how to plan for children's individual needs, and how she will monitor and observe children's progress.
- The childminder appropriately demonstrates how she plans to promote children's safety and welfare. For example, she intends to ensure that risk assessments of the premises are carried out each day and that her home is kept secure.
- The childminder demonstrates a good awareness of how best to support children's learning about a healthy lifestyle and diet. She understands the importance of providing children with a choice of healthy snacks and meals, and daily opportunities for fresh air and exercise. She also understands how to positively manage children's behaviour.
- The childminder has a good awareness of child protection procedures and has attended training to keep her knowledge up to date. She fully understands the correct procedures to follow should concerns arise about a child in her care, including any allegations against herself or a family member.
- The childminder has a clear understanding of the importance of working in partnership with parents and other early years providers, in order to promote continuity in children's care and learning.
- The childminder has a good understanding of how to assess the provision's strengths and areas for further development. She plans to reflect on her practice and attend training to keep her knowledge up to date.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
