The setting does not meet legal requirements for early years settings

Summary of key findings for parents

The provision does not meet requirements

- The childminder does not hold a current paediatric first-aid qualification. Consequently, she does not have an up-to-date knowledge of how to deal with accidents and injuries to ensure children's safety and well-being.
- The childminder demonstrates that she is aware of the Early Years Foundation Stage learning and development, and assessment requirements. She identifies guidance documents that she will consult to help her to ensure that children are challenged successfully so that they make progress.
- The childminder explains a good settling-in procedure in order to assure the emotional security of early years children.
- The childminder successfully minimises risks in her home and garden. She demonstrates a sound knowledge of what would cause her concern and her responsibilities to protect children from abuse and neglect.
- The childminder identifies through discussion how she has addressed the recommendations raised at the time of her last inspection. She has reviewed her provision so that she is prepared to meet the different learning needs of children in the early years age group.
- The childminder provides a variety of resources that meet the needs of early years children at different stages of development.
- The childminder is aware of records, policies and procedures that are required for the safe and efficient management of the Early Years Foundation Stage. Documentation that parents are initially asked to complete includes detail on children's individual needs.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

What the setting needs to do to improve further

To meet the requirements of the Early Years Foundation Stage the provider must:

maintain a current paediatric first-aid qualification, so that the safety and welfare of children is assured.

To meet the requirements of the Childcare Register the provider must:

- ensure that an appropriate first-aid qualification is maintained (compulsory part of the Childcare Register)
- ensure that an appropriate first-aid qualification is maintained (voluntary part of the Childcare Register).

Inspection activities

- The inspector discussed with the childminder how she will meet early years children's care and learning needs.
- The inspector looked at a selection of policies and procedures, records and other documentation that the childminder has prepared for when she begins caring for children.
- The inspector observed areas of the home that will be used for childminding.
- The inspector looked at the childminder's training certificates and checked evidence of suitability for the adults in the household.
