Summary of key findings for parents

The provision meets requirements

- The manager understands the importance of providing children with interesting activities based on their individual needs and interests.
- The manager understands how to make the facilities welcoming to children. She knows how to organise toys and resources so children can make independent choices.
- The manager knows how to promote children's good health. Activities are organised so children participate in physical activities and have daily experiences outdoors.
- The manager understands the procedures for recording accidents, incidents and the administration of medication. The manager understands the importance of staff maintaining current paediatric first-aid certificates.
- The manager understands the importance of staff knowing their roles and responsibilities concerning safeguarding and protecting children. The manager makes sure staff have attended relevant training and know what to do should they have any concerns about a child's welfare.
- The manager recognises the need to continually develop the club's provision for children through checking and evaluating what is offered.
- The manager has a clear understanding of the importance of working in partnership with parents and others involved in the children's care.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector observed the indoor and outdoor areas used by the children.
- The inspector held discussions with the club manager and centre managers.
- The inspector looked at relevant documentation and checked evidence of the suitability of staff.
- The inspector took account of the views of parents and children by viewing questionnaires and the club's self-evaluation.

Steyning Leisure Centre registered in 2006. It is located in Steyning. The club opens in school holidays from 8.30am until 6pm. The club does not open on bank holidays. There are eight staff working with the children. At present six staff hold recognised qualifications. There were no children present in the early years age range at the time of the inspection.
