#### Summary of key findings for parents

#### This provision is good

- Children benefit from a range of stimulating and exciting resources, especially in the outdoor area. Staff use these to promote challenge and thinking, and help children to make good progress.
- Staff provide rich opportunities for children to develop language skills. They use a range of strategies, such as asking questions, which encourage children to think for themselves and make their own choices.
- Children are fully engaged in their learning as they follow their own interests and ideas. Staff are enthusiastic and encourage children to learn through trial and error.
- Parents have a strong working partnership with staff. They report that they feel informed and involved in their child's learning.
- The manager has rigorous procedures in place to safeguard children. All staff have received training on how to keep children safe. Policies are robust and consider many aspects of nursery routines, including personal care.
- The manager places a strong emphasis on preparing children for their move to school. Staff are dedicated to helping children to learn key skills for school, such as self-care and early reading strategies.

#### It is not yet outstanding because:

Staff do not always make use of daily routines to continually promote children's independence. For example, children are not always encouraged to pour their own drinks.

### What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

enhance opportunities for children to develop independence skills during daily routines, such as pouring their own drinks.

#### **Inspection activities**

- The inspector observed activities in the playrooms and the outside play areas.
- The inspector looked at some children's records, including their learning assessments, and spoke to some key persons.
- The inspector spoke to parents and took account of their views.
- The inspector held meetings and completed joint observations with the manager of the nursery.
- The inspector checked evidence of safeguarding practices, staff recruitment, ongoing professional development and self-evaluation processes.

### **Inspection findings**

## How well the early years provision meets the needs of the range of children who attend. This is good

Staff use their knowledge of children's development to provide a wide range of stimulating activities. Children also initiate activities themselves and are skilfully supported by staff. For example, children's interest in objects that roll leads them to be competitive. Staff extend this learning by encouraging them to begin to compare and predict through playful races. These high-quality interactions enable children to acquire new skills. Staff have high expectations of children's learning and provide appropriate challenge to develop children's thinking skills. Children of all ages are keen to interact with staff and enjoy cuddles when they read stories together. Older children enjoy interactive activities and spontaneous song to enhance their play. This promotes a positive learning environment where children feel happy and secure.

## The contribution of the early years provision to the well-being of children is outstanding

Children and staff have excellent relationships. Staff are exemplary role models and they consistently promote very good hygiene habits, such as hand-washing, to help keep children healthy. Staff use memorable phrases to help children to learn appropriate behaviours, such as 'sharing is caring'. Parents speak freely to staff and turn to them for advice on managing children's behaviour at home. Staff encourage this two-way flow of information and use a range of effective strategies to communicate with parents and involve them in their child's learning. As a result, parents know about their child's progress and next steps in their learning. Parents feel confident that their children are safe as there are rigorous and robust measures to ensure children's well-being is always a top priority.

## The effectiveness of the leadership and management of the early years provision is good

The manager consistently reflects on practice to identify areas to improve and introduces changes to benefit children. For example, she has reviewed arrangements for planning to make them more robust and enable staff to make immediate changes. This means staff can now respond to children's changing interests and any observations parents share. The manager has also strengthened the procedures to support staff and their development. Records are more detailed, and regular meetings and supervisions mean that staff work together towards shared goals. The manager responds to ideas staff bring from training and implements changes suggested by other professionals. She works closely with local school teachers so that children are a welcome extension of the school community from the outset. This means children move smoothly on to the next stage of learning.
