The provision meets requirements

- The childminder has knowledge and understanding of the Early Years Foundation Stage and how to support children's learning and development. She understands how to support children to be prepared for school.
- The childminder understands how to support children's emotional well-being, and how to develop secure relationships with them and demonstrates an effective settling-in process.
- The childminder demonstrates an understanding of how to provide a range of resources and learning opportunities to support children's self-motivation and engagement in learning.
- The childminder demonstrates and understanding of the importance of self-reflection and continuous improvement to ensure quality of provision for all children.
- The childminder understands how effective partnerships with parents and other professionals supports children, including children with special educational needs and/or disabilities, to progress from their starting points.
- The childminder understands how to implement effective behaviour management strategies to support children's emotional well-being.
- The childminder demonstrates an understanding of how to keep children safe in line with an effective safeguarding policy.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

The childminder was registered in 2003 and lives in the Chorlton area of Manchester. She operates all year round, 7.30am to 6.30pm, Monday to Friday, except bank holidays and family holidays. She holds a formal qualification equivalent to Level 3. The childminder is a member of the Professional Association for Childcare and Early Years. There were no children on roll in the early years age range at the time of the inspection.
