## **Requires improvement: monitoring inspection visit to Monyash CofE Primary School**

Following my visit to your school on 27 April 2015, I write on behalf of Her Majesty's Chief Inspector of Education, Children's Services and Skills to report the inspection findings. Thank you for the help you gave to me and for the time you made available to discuss the actions you are taking to improve the school since the most-recent section 5 inspection.

The visit was the first monitoring inspection since the school was judged to require improvement following the section 5 inspection in February 2015. It was carried out under section 8 of the Education Act 2005. The school was also judged to require improvement at the previous section 5 inspection.

Senior leaders and governors are taking effective action to tackle the areas requiring improvement identified at the recent section 5 inspection.

### Evidence

During the inspection, meetings were held with the executive headteacher, the school's mathematics coordinator, representatives of the governing body, and a representative of the local authority. A brief conversation was held by telephone with a representative of the diocese. The inspector toured the school, visiting both classrooms and holding discussions with pupils. The school's improvement plan was evaluated.



# Context

There have been no changes at the school since the inspection.

## **Main findings**

The school has experienced a period of significant difficulties in leadership and staffing recently. The local authority has acted successfully to stabilise the staffing and leadership in the short term. The long-term arrangements for the school are still uncertain; however, which is potentially a barrier to the school's continued improvement.

You have taken several initiatives, which are leading to the required improvements in the quality of teaching. The teachers have been provided with practical advice on the teaching of mathematics. They are now putting the advice into practice. For example, the pupils told me about the 'maths challenge' booklets that they are now using.

The teachers have been given some initial opportunities to visit other schools and observe good teaching practice and are using some of the techniques they have observed to set more-challenging work for the pupils. For example, the pupils explained to me how the 'next steps' that they are given to do involve them in moredifficult work.

The governing body is increasingly well informed about what is happening in the school. You have helped it to become so by setting up with the governing body a series of purposeful activities, which is helping it to gain at first hand an understanding of the school's progress. The external review of governance, though planned and offering the prospect of further improvements, has not taken place, however, and the arrangements for it need to be firmed up as a matter of urgency.

You revised the school improvement plan, with the involvement of the governing body, after the recent inspection. The plan, clearly, incorporates the areas for improvement from the inspection. I discussed with you some ways in which the plan could be improved, including by making the proposed timings of activities more precise.

Ofsted may carry out further monitoring inspections and, where necessary, provide further support and challenge to the school until its next section 5 inspection. I have recommended that a further visit takes place to monitor the progress of the school, with particular reference to sustaining improvements in leadership and management.



#### **External support**

You have established a close and productive working relationship with the local authority. The support provided, endorsed by the diocese, has been essential to the improvements at the school.

I am copying this letter to the Chair of the Governing Body, the Director of Children's Services for Derbyshire, and the Director of Education for the Derby diocese.
