Summary of key findings for parents

The provision meets requirements

- The childminder understands her responsibilities and the procedures to follow relating to safeguarding children and protecting their welfare. She has written policies and procedures in place which she will share with parents.
- The childminder intends to build caring relationships with children to help them feel relaxed and secure in her care. She has a wide range of play resources. She has organised these so children can make independent choices about what they play with.
- The childminder understands the learning and development requirements. She will establish children's individual starting points with their parents. She intends to use observations and assessment to plan activities that help children make progress and to identify if any extra support may be needed.
- The childminder understands the need to work with parents and other settings children attend to share information about children and support their progress. The childminder understands the need to evaluate her service.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.
