Summary of key findings for parents

The provision meets requirements

- The childminder has a good range of resources, toys and activities to meet the areas of learning. She confidently explains how she supports and progresses children's learning and development.
- The childminder demonstrates a good understanding of how children learn and develop. Through discussion, she explains how she adapts the environment to meet the needs of all children.
- The childminder recognises the importance of promoting children's well-being. She is aware of developing close relationships and emotional bonds with all children, to help them feel secure and safe.
- The childminder confidently discusses how she promotes children's understanding of a healthy diet and the importance of physical exercise.
- The childminder demonstrates a good understanding of how to develop positive relationships with parents. She understands the importance of sharing information about children's learning and care requirements.
- The childminder has a valid paediatric first-aid certificate, which means she is trained to treat children's minor injuries.
- The childminder has a good range of safeguarding policies and procedures. She explains how she risk assesses her environment to promote children's safety.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

- The inspector discussed with the childminder her understanding of how to monitor, assess and progress children's learning.
