Summary of key findings for parents

This provision is outstanding

- Staff actively ensure that all areas of learning are promoted throughout the day, although they have identified scope to extend the range of technology available for children to explore.
- Staff make excellent use of observations and assessment to identify areas in which to further promote children's learning and development.
- Staff actively involve parents by asking them to contribute to records of their children's learning and by regularly sharing information with them.
- Differences are highly valued and positively promoted. Children learn about other cultures, faiths and traditions. For example, the role-play area is set up as a French restaurant and children are given the opportunity to try croissants at snack time.
- Staff have interesting and exciting ways of preparing children for their move to school. For example, by making books for each child containing photographs and information on their new setting.
- All staff demonstrate a clear understanding of how to keep children safe and are able to accurately identify any signs of harm.
- Staff strive for excellence and make use of highly accurate, honest and realistic selfevaluations to identify areas for improvement.
- Staff actively share their skills and expertise with others. Children benefit from this as all staff contribute to planning stimulating and interesting activities for them.
- Staff actively identify ways in which to help children who need additional support.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

enhance further the opportunities for children to explore technology.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is outstanding

Children have access to an extensive variety of exciting and interesting resources. Resources are displayed in such a way that all areas of learning and development are promoted. Children are extremely motivated and eager to participate in all activities as they are presented in such an exciting way. All staff have exceptional knowledge of the children's needs and abilities and are highly efficient in supporting and extending their learning. Staff actively engage in consistently high-quality interactions with children. As a result, children flourish and most are developing beyond expectations. Parents speak very highly of their partnerships with staff and of the valuable information that is shared with them. Parents are given the opportunity to contribute to information on their children's learning and development. This helps to provide a rounded view of children's development as achievements from home are also shared. Staff value diversity and parents of different cultures are invited to visit the setting in order to share information on topics such as their traditional clothing, food and languages spoken.

The contribution of the early years provision to the well-being of children is outstanding

Staff work in excellent partnership with other professionals to meet the needs of children with special educational needs and/or disabilities. They share all the necessary and relevant information and also ensure that this information is passed on when the children move settings. Staff consistently encourage and promote independence. As a result, children are comfortable to take risks and explore their surrounding environment. This also helps to prepare children for their move to school. Children follow excellent hygiene routines and understand the importance of drinking water regularly and washing their hands before eating. All staff demonstrate a clear understating of the procedure to follow in the event of any suspected harm to children. Staff undertake regular risk assessments to ensure the safety and suitability of the environment for children.

The effectiveness of the leadership and management of the early years provision is outstanding

Leadership is inspirational and all staff are motivated to achieve and to constantly improve practice. They regularly attend courses and share their knowledge and areas of expertise. As a result, children benefit from staff's expert knowledge and understanding of how children learn. Staff undergo annual appraisals and set realistic and achievable goals for personal development. Staff also contribute to highly accurate and robust self-evaluations of the service provided. They take into account ideas and opinions provided by parents and endeavour to effectively implement them. Staff also consider children's enjoyment of, and the success of, planned activities in order to drive improvement.
