Summary of key findings for parents

The provision meets requirements

- Staff have a good understanding of their role and responsibilities to protect the welfare of children in their care. They are very clear about the child protection procedures approved by the Local Safeguarding Children Board. They are confident in their ability to take action to help keep children safe from abuse or neglect.
- Leaders and managers have a good knowledge and understanding of the learning and development requirements of the Early Years Foundation Stage. Staff know how to observe, assess and plan for children's future development.
- Leaders and managers understand their responsibility to notify Ofsted of any changes that may affect the space they use, or the quality of the childcare that they provide.
- Staff have a good understanding of how to teach children that some behaviour is unacceptable and help them learn to work together.
- Staff have a good understanding of how to provide children with a healthy diet and teach them the importance of physical activity. This promotes children's health.
- Leaders and managers understand the benefits of working in partnership with parents and other professionals, to ensure children's individual needs are met. They have a selection of policies and procedures to share with parents. This helps them to understand how the setting operates.
- There is a good variety of resources and equipment for children from the age of three years. The resources and equipment are well presented and easily accessible. Staff check them on a regular basis to ensure they are suitable for children to use.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector toured the areas of the premises where childcare is to be provided.
- The inspector discussed with the manager how she intends to deliver the educational programme for children.
- The inspector looked at policies and documents the manager will use when caring for children.
- The inspector checked evidence of the suitability and qualifications of the staff working with children.

Holy Rood Out of School Club was registered in 2009. It is privately owned. The club employs four members of childcare staff. Of these, two hold appropriate early years qualifications at level 4. The club opens Monday to Friday, from 7.30am to 9am and 3.30pm to 6pm, during term time only. It supports a number of children with special educational needs and/or disabilities.

This inspection was carried out by Ofsted under sections 49 and 50 of the Childcare Act 2006 on the quality and standards of provision that is registered on the Early Years Register. The registered person must ensure that this provision complies with the statutory framework for children's learning, development and care, known as the Early Years Foundation Stage.
