Summary of key findings for parents

The provision meets requirements

- The childminder understands how to meet the learning and development requirements. She understands how to provide enjoyable experiences for children of different ages, abilities and backgrounds to challenge their thinking and promote learning in all areas.
- The childminder understands how to meet individual children's needs and the importance of completing assessments of their progress at the age of two years.
- The childminder understands the importance of working in partnership with parents and statutory agencies to determine when additional help is required for children.
- The childminder keeps the documentation required for the safe management of the provision in order to keep children safe from harm, including through undertaking risk assessments.
- The childminder knows how to organise a range of resources to help children to make independent choices during their play.
- The childminder understands how to promote children's well-being. She knows the importance of providing healthy food and for children to have daily outside experiences. She understands how to manage children's behaviour in a positive way.
- The childminder has good knowledge of child protection requirements and understands her responsibility to protect the welfare of the child.
- The childminder knows the importance of continually evaluating her practice to improve what she offers children.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children. The report states whether the provider continues to meet the requirements of registration.

Inspection activities

- The inspector held discussions with the childminder to assess her knowledge of the safeguarding and welfare, and learning and development requirements of the Early Years Foundation Stage.
- The inspector sampled the childminder's documentation including children's records and background suitability checks, and discussed her policies and procedures.
- The inspector viewed the areas of the home that children have access to when they are present, and the resources available for childminding.
