### Summary of key findings for parents

#### This provision is good

- Children eagerly play and explore the home-like environment. Staff set out a good range of resources and toys, ensuring children are able to access them independently.
- Staff use observations and assessments effectively to plan for children's next steps in their learning. This means they make good progress in relation to their starting points.
- The management and staff have clear expectations, and praise children's attempts and achievements. Children behave very well, and are extremely confident and self-reliant.
- The management develops strong partnerships with parents and professionals to ensure individual children's needs are met well.
- The management demonstrates a good knowledge and understanding of the child protection procedures and of how to safeguard children.
- Parents report that they are extremely happy with the service provided and that staff effectively meet the needs of their children.
- The management and staff attend training to update their knowledge and skills, and to gain qualifications. This enables them to improve outcomes for all children.

#### It is not yet outstanding because:

- Children have fewer opportunities to see letters and numbers in the outdoor environment, to learn that words have meaning.
- Staff do not consistently provide older children with sufficiently challenging activities based on their interests.

### What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- enhance the outdoor area to give children more opportunity to see signs and symbols to further develop their interest in literacy
- strengthen the range of experiences on offer for older children, to continually challenge and motivate them further.

#### **Inspection activities**

- The inspector observed activities in the playroom and the outside learning environment.
- The inspector spoke to parents about their views on the service that they receive.
- The inspector talked to the providers about the pre-school practices and how they drive forward improvement, and discussed their action plan.
- The inspector undertook a joint observation with the provider.
- The inspector sampled relevant documentation including children's developmental records.

### **Inspection findings**

# How well the early years provision meets the needs of the range of children who attend. This is good

The management and staff provide children with an exciting array of resources and activities. This supports their learning well and prepares them for school. For example, the children enjoyed exploring how to fit the tubes together to complete the marble run. Staff introduced mathematics as they counted the marbles with the children. Staff make effective use of activities to extend the children's vocabulary and support their communication and language. They encourage children to predict what will happen next at story time. The staff recite the rhyming words of the story and together they think about what other words rhyme. Staff use daily routines to begin to teach the children a range of Spanish words. They enhance the children's interest in language with the introduction of signs in different languages around the playroom. Staff encourage children to initiate their own learning and to continue their learning at home. For example, the children choose which book they wish to take home to share with their parents.

# The contribution of the early years provision to the well-being of children is outstanding

Children are extremely comfortable in the care of staff due to the well-established settling-in procedures. As a result, children's emotional well-being is excellent. Staff work extremely closely with parents to gather a wide range of information about children's likes, dislikes and care needs. As a result, staff meet children's needs very effectively. Staff teach the children about the importance of a healthy lifestyle. The children are eager to investigate the secure garden area to develop their physical skills. They also go on regular walks in the local community, to learn about the world around them. Consequently, children are developing an excellent understanding of how to keep themselves safe and healthy.

# The effectiveness of the leadership and management of the early years provision is good

The owners have a secure knowledge and understanding of the learning and development requirements. The management routinely reviews children's progress to ensure children make good progress. They maintain a safe and secure environment through effective daily risk assessments. The managers support and manage staff effectively through individual supervision meetings, which help to identify staff training needs. They continually evaluate their practice and set targets for improvement. They engage parents in helping to evaluate the service they provide by sending out regular questionnaires, therefore demonstrating a strong commitment to improving the quality of practice and children's learning experiences.

Kelso House Pre-school registered 1993 and is located in Margate, Kent. The pre-school is open five days a week, from 9am to 3.45pm, term time only. The pre-school is in receipt of funding for the provision of free early education for two-, three- and four-year-old children. The staff support children who have special educational needs and/or disabilities and those who speak English as an additional language. The pre-school employs four staff of whom two hold appropriate qualifications at Level 3. In addition, one of the owners holds a BA (hons) degree in early education.
