## Summary of key findings for parents

#### This provision is good

- The childminder provides a welcoming and well-resourced playroom for children. This provides good opportunities for children to make safe and independent choices in their play. As a result, children are excited and motivated to learn and they eagerly join in activities.
- Children form warm and trusting relationships with the childminder. They enjoy interacting with her in both English and Spanish. This helps build on their awareness and value of different cultures and languages.
- The childminder works well with parents and keeps them updated on children's experiences and progress. These positive parental partnerships promote children's learning at home.
- The childminder has a positive attitude to her professional development. As a result, she regularly updates her skills and knowledge to promote further improvement in outcomes for children.
- The childminder has a good understanding of how to promote the health and safety of the children in her care. As a result, children are well cared for and protected.

#### It is not yet outstanding because:

- The childminder does not fully support children to behave as expected during their independent play.
- The childminder does not always maximise opportunities for children to learn about healthy food options and take responsibility

### What the setting needs to do to improve further

#### To further improve the quality of the early years provision the provider should:

- strengthen the ways behaviour is managed, to encourage children to play more cooperatively in groups during independent play
- provide further opportunities for children to learn about healthy food choices and take on responsibilities, for example, by encouraging them to help prepare meals.

#### **Inspection activities**

- The inspector observed activities in the childminder's home and in the garden.
- The inspector spoke to the childminder and children at appropriate times during the inspection.
- The inspector evaluated a planned activity with the childminder.
- The inspector read comments from parents in letters.
- The inspector looked at a selection of policies and procedures.
- The inspector viewed a selection of documents, including children's progress files and discussed these with the childminder.

### **Inspection findings**

# How well the early years provision meets the needs of the range of children who attend. This is good

Children enjoy their time with the childminder and make good progress in their learning. The childminder has a good understanding of the learning and development requirements of the Early Years Foundation Stage. She provides a highly stimulating indoor and outdoor play environment. Young children explore a wide range of sensory materials, textured books and light shows to help support their senses. They sing rhymes with the childminder and join in with simple actions for a spider song. Older children enjoy exploring the concept of weight within the role-play area with real food items and weighing scales. This encourages children to become highly involved in their own learning. The childminder closely monitors children's progress at regular intervals and uses information about children's changing interests to guide and shape her planning. This allows her to precisely target children to help them make the best possible progress in their learning.

# The contribution of the early years provision to the well-being of children is good

Children are happy and settled in the childminder's home. She has a kind, gentle and natural approach, using both English and Spanish dialogue to communicate with the children. Generally the children behave well. During adult-led activities the childminder gives them clear guidance which enables them to focus well. However, during independent play they are less cooperative with their friends, such as sharing toys and taking turns. This does not fully prepare them for being part of a larger group of children, in readiness for school. The childminder provides homemade, wholesome and nutritiously balanced meals. Although she reinforces the message about choosing healthy food options by having bright stimulating posters on display, the children are not actively involved in the preparation of these meals. This does not fully support children to develop a positive interest in foods that will help them stay fit and healthy. Children follow good hygiene routines and older children manage their own hygiene and personal needs well.

# The effectiveness of the leadership and management of the early years provision is good

The childminder is committed to ongoing professional development. Since her last inspection she has completed her early years level 3 qualification and attends appropriate training courses in order to update her knowledge and skills. Consequently, all the safeguarding and welfare requirements are successfully met. The childminder has good links with local authority advisors, who support her to evaluate her provision and make improvements as necessary. As a result, all recommendations from the previous inspection have been met. The childminder works well with other settings children attend, such as nursery. Relevant information is exchanged so that she finds out about children's experiences and learning targets. This promotes continuity in children's learning. The childminder has established strong relationships with the parents. They provide positive feedback regarding children's care, learning and their experiences with the childminder in testimonials, daily diaries and progress reports. The childminder helps parents feel part of their child's time at the setting.
