Summary of key findings for parents

This provision is good

- Children make good progress in their learning and development. They enjoy a variety of valuable experiences which complement those that they take part in at school.
- Children are happy and settled in the out of school club. The relationships between children and the caring staff are strong and the environment is relaxed, fun and safe.
- Partnerships with parents are well established and feedback from parents is very positive.
- The out of school club use the same sanctions and rewards system that are used in school. Furthermore, children have worked well with staff to devise the club's new rules. As a result, children clearly understand the boundaries and expectations set and their behaviour is very good.
- Safeguarding policies and procedures are implemented well. Staff know about the possible signs and symptoms of abuse and the correct procedures to follow if they have concerns. As a result, children are well protected and safeguarded in the out of school club.

It is not yet outstanding because:

- Opportunities to enrich children's knowledge and understanding of the local and wider communities are not fully maximised.
- Staff do not make full use of outdoor areas at different times in the year to help children fully benefit from fresh air and learn about the natural world.

What the setting needs to do to improve further

To further improve the quality of the early years provision the provider should:

- raise the quality of children's learning even further by providing more opportunities for them to find out about different people, events and places of interest
- maximise the use of the outdoor spaces so that children can investigate the natural world and benefit more from being outside during different seasons.

Inspection activities

- The inspector observed activities and spoke with the staff and children at appropriate times throughout the inspection.
- The inspector sampled various documentation including, children's records and selection of policies and procedures. Evidence of the suitability and qualifications of all staff working with children was also checked.
- The inspector also took into account the views of parents spoken to during the inspection.

Inspection findings

How well the early years provision meets the needs of the range of children who attend. This is good

Staff gather valuable information from parents and familiar teaching staff so that they have a good knowledge of children's starting points. This level of detail, along with their own observations, is used well to plan a wide range of stimulating experiences. These reflect children's interests and support their next steps in learning throughout the school year. Children are invited by staff to decide about different themes and to help plan activities. This involves them well in their own learning as they enjoy making choices about what they want to do while they are at club. For example, children build on a current theme about the world by pretending to be travel agents. They talk about holidays and places they have visited, using the map of the world as a reference. Staff explain that they used to have regular visitors coming to the club to share information and experiences with the children. However, this has not been done for a while. As a result, valuable opportunities for children to develop their knowledge of people, places and events are missed.

The contribution of the early years provision to the well-being of children is good

Children thoroughly enjoy being outside in nice weather. They take different resources outside, such as rackets and balls and sheets to make dens. Children also help to organise group games or play on the school's cargo nets and climbing wall. However, there are limited activities which encourage children's awareness of nature and other benefits of the great outdoors. For example, staff explain that children have not been digging, planting and harvesting fruit and vegetables so far this year. Inside, staff provide a well-resourced and welcoming environment and there is a friendly atmosphere. Children chat happily about their day with their key persons who know them well. They also receive lots of praise and encouragement, which builds children's confidence and self-esteem. Staff encourage them to make firm friendships with children in different school classes. As a result, children's emotional needs are well met and their social skills are enriched.

The effectiveness of the leadership and management of the early years provision is good

Staff have a good understanding of their roles and responsibilities to meet the requirements of the Early Years Foundation Stage. Comprehensive and regularly reviewed policies and procedures are made accessible to parents. There are also informative displays and samples of children's artwork which decorate the walls. This helps parents to know how the club operates and shows how children's achievements are valued. All staff also work within the host school. They are experienced, appropriately qualified and attend regular training and staff meetings. This and the effective monitoring of individuals and the provision ensures that teaching is consistently good. The staff reflect on each other's performance well and take into account the views of children, parents and staff. They are confident to acknowledge their strengths and have well targeted and achievable plans in place to ensure their continuous improvement.

Rockets OOSC Limited was registered in 2010. The Out of School Club employs six members of childcare staff. Of these, three hold appropriate early years qualifications at level 3. They are open each week day, during term time only. Sessions are, from 8am to 8.45am and 3.15pm to 6pm.
