- The childminder understands how working in partnership with parents promotes children learning and well-being. She demonstrates a positive approach towards establishing effective partnerships.
- The childminder demonstrates a positive attitude towards her professional development and improving the quality of her provision. She does this through her attendance on relevant training and through the action taken to improve her practice since her last inspection.

There were no children present when this inspection took place. The findings in this report are based on evidence gathered from discussions with those who care for the children and an inspection of the premises, equipment and relevant documentation. Where there are no children present, no judgement is made on the quality of the early years provision as there is no reliable evidence on which to assess its impact on children.
